Possible to apply for funding from the federal \$4.5 million abandoned boat program though reports are that the application process is cumbersome. Checking with Howe Sound applications and look to MP for feedback. Very, few public support McNab gravel/Burnco proposal. BC Ferries Langdale Terminal rezoning Public Hearing on February 21 which is distinct from BC Ferries own Terminal Development Plan. Elphinstone Crossing phase 2 subdivision requires a rezoning to allow for the 18 lots which are outside of the fire protection district. Short term rental issue going before the APC. SCRD budget expecting a 2.8% increase because of mandatory expenditures. Recreational operating budget is now \$4.5 million.
